

VISITOR'S ACKNOWLEDGEMENT OF RISKS FORM

In consideration of the services of **Northwest Navigation Co. Inc. and vessel David B**, their officers, agents, employees, and stockholders, and all other persons or entities associated with those businesses, herein referred to collectively as "**Northwest Navigation**" I agree as follows:

- Although **Northwest Navigation** has taken reasonable steps to provide me with appropriate equipment and skilled guides so I can enjoy an activity for which I may not be skilled, Northwest Navigation has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the activity. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be the cause of loss or damage to my equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death.
- **Northwest Navigation and the Crew of the David B** does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks.
 - I understand that there are inherent risks involved in being on a boat, including but not limited to equipment failure, perils of the sea, acts of other participants, and adverse sea and weather conditions, and I hereby assume such risks.
 - I understand that I have duty or exercise reasonable care for my own safety and I agree to do so.
 - I assert that I am physically fit to be on a boat and to participate in the trip activities of my choosing.
 - I fully understand that the **vessel David B** has limited medical facilities and that in the event of illness or injury, appropriate care may need to be summoned by radio and treatment may be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.
 - I understand **Northwest Navigation** has made no representations to me, implied or otherwise, that they or their crew can or will perform safe rescues or render first aid. In the event I show signs of distress or call for aid, the Crew of the David B will attempt to perform rescue or first aid.
- I am aware that **Cruising on the vessel David B** entails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks.
- I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of **Northwest Navigation** has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.
- I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.
- I have carefully read, clearly understood and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, assigns, personal representative and estate and for all members of my family, including minor children.
