### ALL CRUISES

#### RESERVATIONS:

Trips are sold on a first come first serve basis. We require a non-refundable deposit to guarantee your reservation. You can [contact us](#) or visit our [website](#) for current rates and availability. Please note that rates are per person and do not include transportation to and from the boat.

#### Included in the cost of the trip:

Crew costs, boat costs, meals, including moderate amounts of beer and wine, cabin accommodations, kayaks, permits, port fees and taxes.

#### Not included in the cost of the trip:

Airfare, other types of transportation to and from the boat and lodging before or after the trip. Although we recommend trip insurance, it is not included. Any hospitalization or medical expenses, cost of delays due to acts of nature, war, airlines, illness or any situations beyond our control are not included in the cost.

#### PAYMENTS:

A non-refundable deposit guarantees your reservation. The remaining balance is due 90 days before the trip sails.

#### CANCELLATIONS/REFUNDS:

Reservation deposits are non-refundable.

- 90 or more days prior to departure - 100% payment refund minus non-refundable deposit and \$75 processing fee
- 89-0 days prior to departure - 0% refund

#### TRAVEL INSURANCE:

Travel insurance is strongly advised to protect yourself if you must cancel your trip. Our preferred insurance provider is: [InsureMyTrip.com](#)

#### TIPPING:

Depending upon your experience, a 5 – 15% tip is suggested.

#### SMOKING & WEAPONS:

The David B is a smoke-free vessel. Passengers who wish to smoke can do so ashore. This includes vaping and marijuana. Weapons, of any kind, are not allowed.

#### CHILDREN:

Children above the age of 16 are welcome aboard any of our trips when accompanied by a parent or legal guardian. Children younger than 16 are welcome on whole boat charter trips. **If your child is traveling to Canada with only one parent, a notarized letter authorizing the traveling parent to enter Canada with the child is required for entry.**

#### HEALTH/MEDICAL:

Passengers must be able to judge their level of physical fitness. While trips aboard the David B are not physically demanding, some activities do require a level of fitness to participate in, such as hiking and kayaking.

The crew has the right to prevent a passenger from any activity if it is deemed too strenuous or that he/she is putting his/herself in danger by participating in said activity.

Northwest Navigation Co., Inc. is not held liable and does not refund money for anyone unable to participate in an activity because of crew judgement.

Medical issues, with potential implications for the trip must be made known to the crew before the passenger sails aboard the David B. Northwest Navigation Co., Inc. and our affiliates are not responsible for any special arrangements or medical costs made by passengers who are unable to complete a trip.

### TRIPS TO CANADA

If you have booked a trip that goes to the Canadian Inside Passage or Victoria you are required to bring your passport or Enhanced Driver's License (EDL)/ Identification Card (EID) with you.

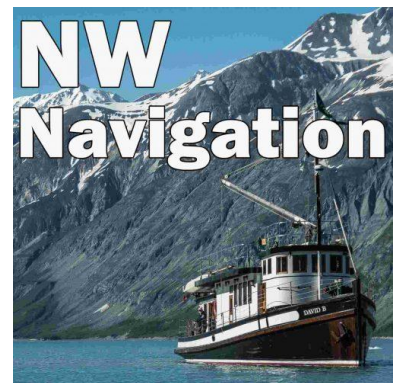
As soon as you make your reservation, but no later than thirty days prior to departure, you will need to furnish us with a scan of your passport or EDL/EID. Both US and Canadian governments require this proof of citizenship. If you have any questions about entry into Canada or the US contact your consulate for requirements.

Please be aware that Canada may restrict entry to anyone who has been convicted of Driving Under the Influence (DUI). Give us call for options.

Canadian Customs also restricts the transportation of firearms, alcohol, tobacco, cannabis and more than \$10,000 in currency.

#### FOREIGN TRAVELERS & VISAS:

If you are traveling from abroad or you are not a U.S. citizen, consult your consulate to determine if you will need a visa to enter into the U.S. or Canada
